









<p><b>Title</b></p>	<p><b>Health and hygiene in housekeeping and hotel operations on passenger ships</b></p> <p>Training course for supervisors, managers and ship crew</p>   
<p><b>Purpose:</b></p>	<p>This course is designed to provide an overview of cleaning and disinfection principles and on how to organize an audit on housekeeping and other public health activities on board so as to verify prevention and control of infections and pest infestations in accordance with the European standards.</p>
<p> <b>Dates:</b></p>	<p><b>Tuesday 10 – Friday 13 November 2026</b></p> <ul style="list-style-type: none"> <li>• <b>Day 1:</b> only self-paced session – participants will have to complete the pre-test, view recorded videos, and complete self-paced exercises at the SHIPSAN e-learning platform.</li> <li>• <b>Days 2-4:</b> combination of live and self-paced sessions. The live sessions will be held at 15:00 CEST (maximum 3 hours per day).</li> </ul>

<p> <b>Course objectives:</b></p>	<p>By completing this course, trainees will be better able to apply the requirements from the 3<sup>rd</sup> Edition of the European Manual in particular to:</p> <ul style="list-style-type: none"> <li>• Verify uniform application of cleaning and disinfection standard operating procedures</li> <li>• Audit housekeeping activities</li> <li>• Audit the Integrated Pest Management (IPM) plan</li> <li>• Assess compliance with infection control processes in nursery and play areas, hairdresser's and beauty salons</li> <li>• Ensure appropriate storage and application of hazardous chemical agents and biocidal product</li> <li>• Audit procedures and practices for the hygienic collection, sorting, storage and disposal of the ship's generated waste-stream</li> </ul> <p>Click <a href="#">here</a> to download the 3<sup>rd</sup> Edition of the European Manual.</p>
<p> <b>Course methodology:</b></p>	<p>This course will <b>combine self-paced online learning (asynchronous) and online live streaming (synchronous) methods</b>. The training approach of the course consists of:</p> <ul style="list-style-type: none"> <li>• Lectures – instruction and theory on the subject matter</li> <li>• Online self-paced exercises – adapting theory</li> <li>• Case studies – use of scenarios to exercise problem solving</li> <li>• Questions and answers – updating skills and knowledge</li> <li>• Resources in the form of support documentation in an electronic format</li> </ul>

**Assessment:**

At the beginning and at the end of the training course, there will be an assessment. It will include multiple choice and short answer questions covering the topics discussed in the course.

**Aim of the assessment:** It is a tool to give a better idea of the trainees' learning progress.

**Administrative Information:****Training fees**

The cost for attendance for this course is **500 euros per participant**.
